

# Privacy Policy

## Privacy statement

The privacy and personal data protection policy applies to all visitors to the website [www.megras.si](http://www.megras.si).

At Megras d.o.o., Noršinska ulica 25, 9000 Murska Sobota, Tax Number SI75183331, Registration Number: 5472261 (hereinafter: The Manager), we respect your privacy and are committed to protecting the personal data we receive from you. Our data protection policy is therefore in line with the applicable provisions in the field of personal data protection as well as with other legal provisions.

## What data do we collect?

You can visit our website without providing your personal information. The provision of personal data is only required if you fill in our contact form Contact.

The personal data we obtain are:

- Name and surname
- E-mail address
- Phone
- The IP address of the user from whom the site is accessed

Personal data received by filling in the Contact contact form is used only for communication by e-mail.

## How do we protect your information?

All the mentioned data is stored permanently on the administrator's server. In no case will we hand over your personal data to unauthorized persons.

The data we collect and process will be disclosed if such an obligation is provided by law, or in good faith that such action is necessary for proceedings before courts or other state authorities and to protect and pursue the legitimate interests of the administrator.

## Right of withdrawal

You have the right, at your own request and free of charge, to receive information about what personal information we have stored about you. You further have the right to request corrections, deletions or prohibitions on the use of incorrect data.

### **Use of Google Analytics**
